Year 6 Residential to JCA Adventure, Condover Hall, Shropshire Sunday 16th March - Wednesday 19th March 2025

Dear Parent/Carer,

We are very excited to be able to offer your child the opportunity to take part in a residential visit to Condover Hall, Shropshire. This will be for a 4 day and 3 night stay from Sunday 16th March to Wednesday 19th March 2025. If you do not wish your child to attend this visit then an alternative curriculum will be offered in school.

We believe that there are many benefits to be gained from engaging in residential, outdoor learning experiences. These include personal and social development, where independence, team work, confidence and self-esteem can be raised and strengthened through fun and challenging group activities. Many of these benefits can be transferred back into the classroom and beyond where they can have real and lasting impact.

Working in teams, your child will participate in a number of adventurous activities. We will send you a more detailed itinerary nearer the time. They will sleep in dormitories with school staff close by.

Funding the visit and Parental Permission

Under our Charging & Remissions Policy, we are asking for payment for this residential visit since the school does not have a budget to cover the cost.

The total cost of the visit will be in the region of £300 to £320, which includes transport, meals, activities and accommodation.

The first instalment will be a **non-refundable** deposit of £ 100 which will need to be paid on your ParentPay account by **Friday** 5^{th} **July** to book your child's place on the trip. You will need to tick the radio consent button in order to make payment.

Full payment will be required by Monday 2nd December in order to secure your child's place.

Please see the full details on page 3 of this letter explaining why we require full payment and a non-refundable element.

We would also like to stress that the children's behavior in school will greatly influence whether or not they are invited to go on the visit. We need to put the children's safety first and be able to trust that all children will follow the instructions given by an adult and be responsible individuals. We hope that parents and carers will support our stance on this and reiterate this message at home.

We will let you know further details as soon as the activities have been finalized. In the meantime, if you have any concerns or would like further information, then please do not hesitate to get in touch.

Funding of the Residential Trip

The school's Charging and Remissions Policy:

explains (under Residential Visit) that the school can charge for the board and lodging element of the residential visits, but we need to also ask parents/carers for a contribution to cover the full cost of the trip in order for it to take place. The costing for the trip includes transport and other costs in addition to the fee for places at the venue.

The school is still required to meet these costs regardless of cancellation of places, which is why we require payment in full and at least a proportion of the fee charged to parents/carers as a non-refundable amount. The school is in budget deficit so this year it is more important than ever that we receive all monies to cover the cost of the trip.

The policy also states (under Voluntary Contributions) that 'No child should be excluded from an activity because his/her parents are unable/unwilling to pay'. If you would like your child to go on the residential trip but due to financial reasons cannot pay any/all of the cost, please could you inform the school office as soon as possible in order for us to determine the shortfall in income prior to final bookings. The policy states (under Voluntary Contributions) that 'when a visit is dependent on voluntary contributions in order for it to take place, it will have to be cancelled if there are insufficient contributions'.
